EXPLANATORY NOTE

The Entrance Examination Program "Social Work and Social-Legal Protection" (Degree: Doctor of Philosophy, Educational and Scientific Program: Social Work, Specialty: 231 Social Work) has been developed by the working group of the Department of Social Pedagogy and Social Work at Pavlo Tychyna Uman State Pedagogical University. The program is designed in accordance with Appendix 11 "Admission Rules for Higher Education in Postgraduate and Doctoral Studies at Pavlo Tychyna Uman State Pedagogical University in 2023" (approved by the decision of the Academic Council of Uman State Pedagogical University, Protocol No. 14 dated April 25, 2023). According to section III of the Higher Education Standard of the third (educational and scientific) level, the degree of Doctor of Philosophy in the field of knowledge 23 Social Work, Specialty 231 Social Work (approved by the order of the Ministry of Education and Science of Ukraine No. 1495 dated December 30, 2021), the program includes an assessment of the acquisition of competencies and learning outcomes defined by the higher education standard for the specialty 231 Social Work at the second (master's) level of higher education. The program is developed taking into account the specific features of the educational and scientific program "Social Work" of the third (educational and scientific) level of higher education (2023). The main purpose of the entrance examination in Social Work and Social-Legal Protection (Field of Knowledge: 23 Social Work, Specialty: 231 Social Work, Third (educational and scientific) level) is to assess the knowledge and skills of applicants. The applicant should know:

- contemporary theories, methodologies, and methods of social and other sciences, including methods of mathematical statistics and quantitative sociological methods, relevant to fundamental and applied research in the field of social work;
- methods of diagnosing, forecasting, designing, and modeling social situations;
- methods and technologies of innovative practice and management in the field of social work;
- norms of communication with representatives of other professional groups at different levels (experts from other fields/types of economic activity);
- methods of interaction between state, public, and commercial organizations based on social partnership;
- criteria for evaluating the social consequences of human rights, social inclusion, and sustainable development policies;
- foundations of effective organization management in the field of social work;
- regulatory and sub-legal acts related to the protection of citizens' rights.

- the legislative framework for social and legal protection of human rights in Ukraine;
- directions of social activities in the field of social and legal protection of individuals;
- the main methodological principles of social and legal work of a social worker;
- specific features of the activities of social protection institutions for different population groups;
- structure and organizational and legal forms of human rights protection in social security and social protection;
- ethical principles, standards, and values of social work.

The applicant should be able to:

- solve complex problems that require updating and integrating knowledge in conditions of incomplete/insufficient information and conflicting requirements;
- critically evaluate the results of scientific research and various sources of knowledge on social work practices, formulate conclusions and recommendations for their implementation;
- use foreign sources in performing tasks of research and applied activities, express oneself in a foreign language both orally and in writing;
- analyze the social and individual context of problems faced by individuals, families, social groups, communities, formulate the purpose and objectives of social work, plan interventions in complex and unpredictable circumstances according to the values of social work;
- evaluate the social consequences of human rights, social inclusion, and sustainable development policies, develop recommendations for improving the normative and legal framework of social work;
- demonstrate initiative, independence, originality, generate new ideas for solving professional tasks;
- determine the methodology of applied scientific research and apply methods of quantitative and qualitative analysis of results, including methods of mathematical statistics;
- demonstrate a positive attitude towards their own profession and behave in accordance with ethical principles and standards of social work;
- analyze and interpret the content of legal acts regarding the protection of individual rights;
- use basic documents related to legal protection;
- interpret legal acts in favor of the rights and interests of citizens.

ASSESSMENT STRUCTURE

The exam questions are assessed on a scale of 0 to 200 points. The overall score for the entrance examination is determined as the arithmetic mean of the scores for each question divided by the number of questions on the exam.
